# Go-Live: How to Prepare

- WVU Research Operations website Access to research systems and guidance
- Bookmark the <u>Research Operations</u> website
- Watch for information in ENEWS, email, listservs and on the WVU+kc dashboard
- Register for training and review training prep materials
- Use the <u>test and training system</u> to become familiar with the system



WVU+kc will remain available to view and print information research proposals. The IRB protocol system will remain "as is."



# Go-Live: Pre-Award Proposal Planning

Date	Action
12/15/24 11:00 pm	Last day for PIs to initiate and <b>submit</b> a proposal to the next level (department, grant admin, COI, etc.) in WVU+kc
1/13/25	Proposals still pending in WVU+kc will be manually entered by Research IT into WRAP. The approval, review, and submission process will be business as usual.
	All new proposals will be PI initiated in WRAP





# Go-Live: Pre-Award Proposal Planning

- Submit as early as possible
- Complete submission planning survey <u>Proposal Submission Survey</u>
- Check with your college Pre-Award contact for guidance
- Contact the <u>Office of Sponsored Programs</u> for concerns ASAP



Any proposals due through January 31, 2025, should be started in WVU+kc by December 15, 2024, if possible.



### Go-Live: Agreements Planning

Date	Action
12/31/24	Last day to submit Clinical Trial registrations and clinical DUA requests in WVU+kc.
1/12/25	Last day to use existing forms and processes to initiate all other agreements.
1/13/25	All agreements are initiated by the PI or the Agreement Offices in WRAP.



Agreement types include CTAs and COE Registrations, SRAs, Master Agreements, Contracts, DUAs, NDAs, MTAs, Invention Disclosures, Facilities Agreements, Subawards, etc.



Sub-awards, COE Registrations, and clinical DUAs will be migrated to WRAP

# Go-Live: COI Planning

Date	Action
1/12/25	Last day to enter information into the Kuali COI system and to use existing forms for outside consulting and foreign partnerships disclosure.
1/13/25	Enter disclosure information into WRAP



Because disclosure data will not be migrated from our current disclosure systems, all users must create their Disclosure Profile in the new system ASAP beginning Jan. 13, 2025, to ensure system integration with Grants and Agreements and to submit IRB Protocols in WVU+kc.



## Go-Live: WRAP COI Disclosure

- Centralized disclosure system
- Automated workflows and integration
- Early disclosure reduces the possibility of delays in OSP and IRB


